## Cookies Policy

Economics of Mutuality Solutions SA (CHE-303.632.505) is a Swiss corporation (*société anonyme*) having its registered office at c/o BfB, Rue de la Corraterie 26, 1204 Geneva ("**EOM Solutions**", "**we**") and which operates a website. EOM Solutions' activity is to transform business models through proprietary capabilities, tools, and leadership development.

The purpose of this Cookies Policy is to describe the processing of information collected during visits to our website and to offer you the opportunity to configure these cookies according to your wishes.

This Cookies Policy does not cover links within our website to any other third party websites.

### 1. What is a cookie?

A cookie is a small text file that is placed on your computer, smartphone or other device when you visit a website. A cookie allows its issuer to identify the terminal in which it is stored, during the period of validity or registration of the cookie.

### 2. Why do we use cookies?

Cookies are used for a number of purposes. They help to make some parts of a website work or work more efficiently, as well as to provide information to the owners of a website about how it is used.

Some of the cookies used on our website are essential for it to function properly, but we also use some non-essential cookies that help us to improve the overall performance of our website. Cookies allow you to choose your connection preferences (e.g., language), to register for our newsletter or to register for conferences, workshops, roundtables or other events we organize or sponsor.

The cookies we issue also allow us to:

- a. identify the terminal and the web browser from which you access our website;
- b. adapt the presentation of our website to the display preferences of your terminal (e.g., display resolution, operating system used) when you visit our website;
- c. establish statistics and volumes of frequentation and use of the various elements composing our website (sections and contents visited, source, last time any digital content was accessed), thus enabling us to improve the interest and ergonomics of our services and our website;
- d. identify the region / country from which you access our website;
- e. memorize information relating to a form which you filled on our website;
- f. implement security measures.

### 3. What cookies do we use?

#### 3.1. Technical cookies

Technical cookies are essential to the functioning of our website. It is through these cookies that you can browse our website and enjoy its features. The settings for technical cookies cannot be changed.

RecentRedirect	b)	30 minutes	Prevents redirect loops if a site has custom URL redirects.
squarespace-announcement-bar	b)	Persistent	Prevents the announcement bar from displaying if a visitor dismisses it
squarespace-likes	b)	Persistent	Shows when you've already "liked" a blog post

squarespace-popup-overlay	b)	Persistent	Prevents the promotional pop-up from displaying if a visitor dismisses it
squarespace-video-player-options	b)	Persistent	Remembers video player selected preferences (volume, playback speed, and quality) for videos uploaded directly to Squarespace
ss_cookieAllowed	b)	30 days	Remembers if a visitor agreed to placing analytics cookies on their browser
Test	a)	Session	Investigates if the browser supports cookies and prevents errors

### 3.2. Analytical cookies

These cookies collect information about how visitors use a website (e.g., number of visits, most visited pages, most visited content). They allow us to know the use and the performances of our website, to establish statistics, volumes of frequentation in order to improve the interest and the ergonomics of our services and the visits on our website.

The data collected will not be passed on to third parties or used for any other purposes than the ones stated below. These cookies are for internal use and allow us to measure certain audiences on our website.

You can set your browser to not accept cookies, but this may limit your ability to use our website. You can also opt out of receiving interest-based advertising from certain advertising networks [here](#) (or if located in the European Union, [here](#)).

### 3.3. Social Media cookies

Our website contains data hosted or shared to other websites that allow you to view content on our website. When you consent to the use of such social media services, third party cookies relating to the relevant social network are installed. These cookies make it possible, in particular, to link the content consulted to your user account with the social network.

### 3.4. How to configure cookies?

The recording of a cookie in a terminal is generally subject to the consent of the terminal user. Several possibilities are offered to configure cookies: you can choose, at any time, to express and modify your wishes regarding cookies.

#### General configuration

The configuration of each browser is different and is described in your browser's help menu, which will let you know how to manage your cookies preferences.

If you have enabled cookies on your device in your browser software, cookies embedded in pages and content you have viewed may be temporarily stored in a dedicated area on your device.

#### Specific configuration on our website

When you consent to the use of cookies, this consent is valid for a maximum of 30 days, after which you will be asked to renew your consent. This renewal may also occur if you connect from another terminal or if you change your browser settings, or when our website is updated.

If you refuse to accept cookies on your device or on our website, or if you delete your cookies stored on your device, you may not be able to use certain features of our website.
